PART I. General Expectations

Mann Middle School agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. Description of how Mann Middle School will implement the required components of the campus Title I Parent Engagement Plan.

1. Mann Middle School will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:

- Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
- Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Teachers will nominate and vote on the parent (s) to be invited to the Title I meeting. The parent will be contacted via phone and by a letter invitation. A translator will be available. We will provide a brochure explaining our school's Title I procedures.

2. Mann Middle School will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:

- Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Staff will be selected by electing each department head. Parents will be nominated by department heads. Michelle Cockrell will be leader of the Campus Improvement Plan team and will explain and revise with the team and parents our Campus Improvement Plan.
- Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - Staff support trainings will take place during staff development at the beginning of the school year.
- Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.

3. Mann Middle School will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:

- Meet and Greet, Back to School Night, tabling during registration, and parent meetings.

4. Mann Middle School will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- During registration we will have an informational table with pamphlets to explain Title I. Lupe Kelly will be at the table to explain these procedures. In October teachers will be required to conduct parent conferences to explain and show parents their child's goals and how these goals will be assessed throughout the year.

5. Mann Middle School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Each month our welcoming hallway board will be updated with upcoming educational events. A suggestion box will be provided in the front office for parents to place their input. These will be read and addressed each six weeks.

6. Mann Middle School will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- An informational flyer will be sent home with report cards with instructions on how to access their child's STAAR scores on-line. This is in English and Spanish. Also these instructions will be provided during registration.

7. Mann Middle School will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following: (list your own examples here):

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.

8. Mann Middle School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. At each of the following events, information will be passed out to parents regarding our present academic activities taking place at Mann Middle School.

- Book Fair
- Tailgate Party
- Eveline Rivers Coat Night
- Discovery Center Night
- Skyward Parent Training

9. Mann Middle School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to

implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Meet the Teacher Night

10. Mann Middle School will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Hold an orientation for parents of new students with a translator present.

11. Mann Middle School will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Use the language line
- Send information flyers home in English and Spanish
- Have translators available

PART III. Discretionary Components of the Mann Middle School Title I Parent Engagement Plan

Mann Middle School may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:

- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training.
